Typical financial aid awards usually cover the fall and spring terms. If you will be attending the summer term and are interested in financial aid, you must inform the Student Service Center by submitting this Summer Aid Request Form. Once the Financial Aid Office receives this completed form and you have a completed financial aid file for 2020-2021, they will put a financial aid award together for you that will include the summer term. It is important to note that summer aid is limited to the Federal Pell Grant (if eligible), the Ohio College Opportunity Grant (if eligible), and federal loans (if eligible and taking at least six credit hours).

## Important Summer Financial Aid Facts...Please Read!!

- Federal and state grants for summer cannot disburse until after July 1, 2020.
- Summer aid is only available to students enrolled in a degree program at Walsh University.
- Summer aid requests can only be processed once your financial aid file is complete.
- You will receive a Financial Aid Award Notification once your summer aid request has been processed.
- To be eligible for a Direct Loan in the summer, you **MUST** be enrolled in at least 6 summer credit hours. If also enrolling in the upcoming fall and spring semesters (for at least 6 credit hours each semester), your loan will be divided into three equal disbursements.

I also understand that if there is a change in my summer enrollment status, I am responsible for notifying the Student Service Center immediately, since it may affect my eligibility for summer aid.
